#### **Making a Nomination**

Anyone may make a nomination to the USTA Heart of America Hall of Fame by providing the selection committee with ample biographical information about the nominee who may be living or deceased. The committee, following the USTA Missouri Valley guidelines, will annually select from zero (0) to three (3) inductees using the following criteria:

1. USTA Heart of America resident for five or more years
2. Players must have participated in numerous Heart of America, Missouri Valley and/or National Championships, gaining a ranking high enough to be considered an outstanding player
3. Others who have made a substantial contribution to tennis as a: a) director of tournaments, clinics, recreational programs, or other tennis activities for the general public (e.g. promoter or manufacturer); b) coach; c) teaching professional; d) umpire; e) administrator of the game.
4. High standards of sportsmanship & character.

NOTE: All information should be supplied by the nominator. Nominations are due for 2025 by Sun., June 29th

#### **Background & Inductees**
