2.5 & 5.0 → **2doubles 1 Single**

REGISTRATION DEADLINES

1. Captains must register by **Monday, August 3, 2026.**
2. Captain Registration Fee: \$12.00. Captains use the Captain Team Number for your level of play to register.
3. **Mail \$275 deposit check to applicable Level Coordinator - check payable to USTA HOA.**
4. When Captain registration closes and deposit check is received by your level Coordinator, you will receive your “official team number”.
5. All players must register using their official team number before they play. Captains will be moved to their team. If you’re not a playing captain let your level coordinator know.
6. Player registration fee is \$25.00 plus Tennislink Fee.
7. **Majority of players should register by Monday August 24th, 2026.**
8. Players **MUST BE REGISTERED PRIOR** to the start of their first match to avoid a default.
9. Deposit checks will be destroyed at the end of the season if there is not a team default or

courts are cancelled 24 hours in advance of the match time.

USTA MEMBERSHIP

All players must be current members of the USTA and registered on TennisLink. The membership must be current through February 2027

NTRP RATING

1. Year-end Ratings will be available on TennisLink in early December 2026. Simply click on “Find A Rating”.
2. A player may play in more than one NTRP level during the same season. A player may play up only one level.
3. Any player without a valid computer rating may “self-rate” on TennisLink.

FORMAT

The 18 & Over Winter League team should consist of at least 10 players but not more than 18 players, with at least 50% at level.

50% OF PLAYERS SHOULD BE AT LEVEL AND TEAMS MUST MAINTAIN THIS THROUGHOUT THE SEASON.

Each match has a **two-hour** time limit including a ten- minute warm-up. Each match is the best two out of three sets, regular scoring. A 10-point tiebreaker, will be played in lieu of a 3rd set.

All computer-rated players must play in a minimum of 2 matches during the season to participate in post season play(1 default counts). Self-rated or appealed players must have 3 played matches (no defaults allowed).

COURT COST

Indoor Court fee is \$23 per player per match. Clubs provide balls. If a match is outdoors because a club doesn’t have indoor courts cost will be \$15 per player clubs provide balls.
