REGISTRATION

DEADLINES

1. Captains must register by **Monday, August 17th, 2026**. Captain Registration Fee: \$12.00. Captains use the Captain Team Number for your level of play to register the team.
2. Mail \$ 275 deposit check to the League Coordinator - check payable to USTA HOA. **Deposit checks will be destroyed at the end of the season if your team has no defaults or provides clubs with 24-hour notification in the event you need to default a court.**
3. When registration closes and your deposit check is received by Coordinator, you will receive your "official team number".
4. All players must register using their official team number before they play their first match.
5. Player fee is \$25.00 + Tennislink fee.
6. A majority of team members should be registered by Monday August 31st, 2026.. Players may be added to the roster up to 1 week before the final regularly scheduled match.
7. Players MUST BE REGISTERED PRIOR to the start of their first match to avoid a default.

USTA MEMBERSHIP

All players must be current members of the USTA and registered on TennisLink. The membership must be current through March 2027.

NTRP RATING

1. 2025 Year-end Ratings are available on TennisLink. Simply click on "Find A Rating".
2. A player may play in more than one NTRP combo level during the same season.
3. Any player without a valid computer rating may "self-rate" on TennisLink.

COURT COSTS & BALLS

Matches will be played indoors. Players will pay \$23 per player for court fees directly to the club. Clubs will provide a can of balls per court.

FORMAT

***MO Valley rules: Mixed 55 & over: No more than 12 players on a team may advance to sectionals. Captains can have up to 16 players on their roster but only 12 can advance to sectionals.**

The combined ratings of the pair on each court must be equal or less than the league level. The difference in ratings for each pair cannot be greater than 1.0.

Each match has a **two-hour** time limit including a ten- minute warm-up. Each match is the best two out of three sets, regular scoring. A 10-point tiebreaker, will be played in lieu of a 3rd set.

POST-SEASON ELIGIBILITY

55 & Over Mixed is an Invitational Sectional. Players must have 1 match played with no defaults counting.
