



2026 USTA Heart of America Tri-Level Leagues Registration Deadline – Monday, June 8

What Is a Tri-Level League?

Tri-level leagues are gender-based teams competing at 3 levels of NTRP in each duel match (3 courts of doubles).

Teams compete at the District Level for the chance to advance to the Missouri Valley Sectional Championships and Tri-Level National Invitational.

In 2026, Heart of America is offering leagues in 3 Tri-Level divisions/levels. The winners of these leagues will advance to sectionals. *However, any player who qualifies to advance on a team in more than one league will only be allowed to compete for one team at sectionals. (2024 MoValley rule)*

Women’s league will be an **indoor league** on Sundays daytime. Men’s will be an **outdoor league** (Plaza Tennis Center) held on Thursdays in the evening. Both leagues **start mid-July**. Indoor court fees \$23/player (balls provided). Outdoor league no court fees (home team provides balls). Roster limit 18.
