

USTA Leagues Refer a Friend Promotion (2021)

The United States Tennis Association Incorporated (“USTA” or “Sponsor”) League Refer a Friend Promotion (hereinafter, the “Promotion”) is offered only to legal residents of the 50 United States (including the District of Columbia and other locales under United States jurisdiction, including Puerto Rico, Guam, American Samoa, American Virgin Islands, and other protected territories), who are 17 years of age or older at time of entry who refers a new or lapsed player who registers for any USTA membership-based League during the Promotional Period (defined below).

Employees, officers, and directors of Sponsor and anyone involved in the development, administration, fulfillment, and execution of the promotion are not eligible to participate. VOID WHERE PROHIBITED.

To be eligible to receive the promotional offer a user must be listed as the “referred by” person during the registration of a new or lapsed USTA membership-based League member with their name and e-mail address included. A new player is defined as someone who has never been a USTA membership based League player. A lapsed player is someone who has not played in a USTA membership based League in the 2021, 2020, 2019 and/or 2018 League years.

If the registering player fails to list the ‘referred by’ person during the registration process, they may email leagues@usta.com with the name and email address of the person who referred them within seven (7) days of their registration.

Qualifying persons will receive a twenty five dollar (\$25) electronic gift card while quantities last. USTA National staff will be responsible for running a monthly report from TennisLink to gather the “referred by” information and verify eligibility. Once verified, the referring person will receive an electronic gift card via email to the email listed in the “referred by” box subject to the following: i) There is no limit to the number of gift cards a referring person is eligible to receive for referring unique players during the Promotion; ii) There is only one referring person allowed per player registration; iii) If a player is referred to multiple teams by multiple persons, each of the referring persons is eligible for a gift card; iv) If a player is referred to multiple teams by the same person, only one (1) card shall be issued to the referring person for that player; v) a new or lapsed player cannot put themselves in the ‘referred by’ field and receive a gift card. Please allow up to 8 weeks for delivery of the gift cards.

Promotional Period begins on June 1, 2021, at 12:00:01 a.m. Eastern Time (“ET”), and ends on December 1, 2021 at 11:59:59 p.m. (ET) or until supply has been exhausted. If you meet the qualifications above between 6/1/21 and 12/1/21 you will be notified on the first notification date listed below.

Qualifying persons will be notified on or around June 30, 2021, July 31, 2021, August 31, 2021, September 30, 2021, October 31, 2021, November 30, 2021, and December 31, 2021.

No cash alternative. The Sponsor reserves the right to cancel the Promotion or amend the terms & conditions at any time at their sole discretion. Sponsor reserves the right to substitute the promotional offer(s) in Sponsor’s sole discretion. Employees, officers, and directors of Sponsor and anyone involved in the development, administration, fulfillment, and execution of
