<b>Tax Information</b>	<b>Tax Deductions:</b> 30% for foreign players <b>Canadian Citizen:</b> 10% tax deduction for prize money up to \$5,000; 30% deduction for prize money above \$5,000		
<b>Medical Testing and Protocols</b>	If you plan to travel internationally, you will need to get tested no more than 72 hours before you travel by air into the United States (US) and show your negative result to the airline before you board your flight, or be prepared to show documentation of recovery (proof of a recent positive viral test and a letter from your healthcare provider or a public health official stating that you were cleared to travel). As a condition of entry, all players and guests are required to show proof of a negative PCR COVID-19 test taken within 96 hours of arriving at the tournament location. Players/guests who do not show proof of the negative test will not be permitted to compete or be onsite. In addition, all main draw singles, main draw doubles, lucky losers, on-site alternates and players who have won first-round qualifying plus all guests will be required to take a PCR nasal test (provided and paid for by the ATP) on Monday. <b>Testing for doubles &amp; singles MD is TBD</b> <b>Please note: Showering on site will not be allowed</b> All persons (international and Americans) flying into the US need to have a negative PCR covid test 72 hours before boarding the plane <b>All players and guests are required to wear appropriate masks at all times except when on court</b>
