<b>Medical Testing and Protocols</b>	As a condition of entry, all <b>unvaccinated</b> players and guests are required to show proof of a negative PCR Covid-19 test taken within 48 hours or a negative Covid-19 antigen test taken within 24 hours of arriving at the tournament location. Players/guests who do not show proof of the negative test will not be permitted to compete or be on site. In addition, all unvaccinated active players, guests, lucky losers, and on-site alternates will be required to take an antigen Covid-19 test (provided and paid for by the USTA) on Wednesday from 7am-12pm. All unvaccinated players and guests must arrive within the established testing time to receive an antigen Covid-19 test. Requests to extend the testing window will not be granted. All <b>vaccinated</b> players, guests are required to show proof of full vaccination (14 days after final dose) in order to be permitted on site. Fully vaccinated players/guests will not be required to show proof of a pre-event Covid-19 test and will not be required to test on Wednesday  All persons (international and Americans) flying into the US need to have a negative PCR covid test 72 hours before boarding the plane. <p style="text-align: center;"><b>All players and guests must complete the daily screening prior to gaining access to the site.</b> <b>All players and guests are required to wear appropriate masks at all times except when on court.</b></p>
