Medical Testing and Protocols	<p>As a condition of entry, all unvaccinated players, player guests, staff and officials are required to show proof of a negative COVID-19 test prior to the event. This includes either a negative antigen test result taken within 24 hours of arrival at the tournament site, OR a negative PCR taken within 48 hours of arrival at the tournament site. Players, guests, staff and officials who do not show proof of the negative test will not be permitted to compete or enter the tournament site.</p> <p>Fully vaccinated individuals, i.e. individuals who have received one dose of a one-dose vaccine or two doses of a two-dose vaccine, do not need to present a negative test result prior to the event. These individuals will also be exempt from testing during the event. The exemption starts 14 days after the last dose (in a 2-dose series or 14 days after the 1-dose series) of the vaccine was administered.</p> <p>Mandatory In-Event Test - Wednesday 7am-12pm at the tournament hotel. All unvaccinated players that are active in the tournament (singles, doubles, lucky losers, alternates), plus all player guests, staff and officials (except 90 day positive tested players noted above) will be required to take a nasal antigen test on Wednesday during the event.</p> <p>All persons (international and Americans) flying into the US need to have a negative PCR covid test 72 hours before boarding the plane.</p> <p align="center">All players and guests must complete the daily ITF screening questionnaire prior to gaining access to the site.</p> <p align="center">All players and guests are required to wear appropriate masks at all times except when on court.</p>	
Practice Courts	Practice courts will be available beginning Sunday, August 8 at 11am. Player and +1 will not be able to practice on site once the player is out of tournament.
