Medical Testing and Protocols	Starting 8th November, all foreign nationals wishing to enter the USA must be fully vaccinated with a WHO recognised vaccine. NIE 212 (f) waivers (including NIEs already issued) will no longer be valid for foreign nationals wishing to travel to the US after this date. Players already in the US prior to 8th November may remain and continue to compete. As a condition of entry, all players, player +1s, officials, tournament staff, and USTA-hired staff (Athletic Trainers, commentator, webstreaming staff, etc.) are required to show proof of a negative COVID-19 PCR test taken within 3 days of arriving at the tournament location or a negative COVID-19 antigen test taken within 1 day of arriving at the tournament location regardless of vaccination status. Players/guests who do not show proof of the negative test will not be permitted to compete or be onsite. In event testing will be held during the event on Thursday for all players, guests and officials who are not vaccinated. All persons (international and Americans) flying into the US must show a negative COVID-19 test taken no more than 1 day before travel to the United States. All players and guests are required to wear appropriate masks at all times except when on court.
