Medical Testing and Protocols	Starting 8th November, all foreign nationals wishing to enter the USA must be fully vaccinated with a WHO recognised vaccine. NIE 212 (f) waivers (including NIEs already issued) will no longer be valid for foreign nationals wishing to travel to the US after this date. Players already in the US prior to 8th November may remain and continue to compete. All non-U.S. citizen, non-U.S. immigrants traveling to the United States by air are required to show proof of being fully vaccinated against COVID-19.
