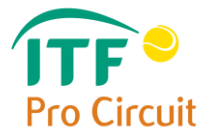

## DIRECTIONS

<b>FROM AIRPORT TO SITE:</b>	TAKE 270 NORTH UNTIL YOU SEE 315 SOUTH TO HENDERSON RD. EXIT. TURN LEFT UNTIL YOU REACH HENDERSON RD. TURN RIGHT AND CONTINUE TO THE 2ND LIGHT, TURN RIGHT AND QUICK LEFT, WHICH WILL PUT YOU IN THE PARKING LOT.
<b>FROM HOTEL TO SITE:</b>	TURN RIGHT ONTO OLENTANGY RIVER RD. AND PROCEED TO HENDERSON RD. TURN LEFT AND GO TO THE SECOND LIGHT. TURN RIGHT AND MAKE AN IMMEDIATE LEFT.
<b>FROM SIT TO HOTEL:</b>	TURN LEFT ON TO HENDERSON RD., CONTINUE EAST UNTIL YOU GET TO OLENTANGY RIVER RD. TURN RIGHT AND CONTINUE PAST RIVERSIDE HOSPITAL, HOTEL WILL BE ON YOUR LEFT.
<b>FROM AIRPORT TO HOTEL:</b>	TAKE 270 NORTH UNTIL YOU SEE 315 SOUTH, TAKE THE NORTHWEST BROADWAY EXIT AND TURN LEFT AT STOP LIGHT. HOTEL WILL BE ON YOUR LEFT.
