DIRECTIONS

FROM AIRPORT TO SITE: HEAD NORTHWEST ON MAIN TERMINAL TOWARD LAMBERT INTERNATIONAL BOULEVARD. TURN LEFT ONTO LAMBERT INTERNATIONAL BOULEVARD. TAKE THE RAMP TO I-70 E/ST. LOUIS. MERGE ONTO I-70 E. TAKE EXIT 238C ON THE LEFT TO MERGE ONTO I-170 N. TAKE EXIT 10B TO MERGE ONTO I-270 E TOWARD CHICAGO. TAKE EXIT 9 FOR IL-157 TOWARD COLLINSVILLE/EDWARDSVILLE. TURN LEFT ONTO IL-157 N/N BLUFF ROAD. SLIGHT RIGHT TOWARD IL-157 N. CONTINUE STRAIGHT ONTO IL-157 N. TURN RIGHT ONTO CENTER GROVE ROAD. SITE WILL BE ON THE LEFT.

FROM AIRPORT TO HOTEL: SAME DIRECTIONS AS ABOVE. ONCE ON CENTER GROVE ROAD, TURN LEFT ONTO PLUMMER DRIVE. HOTEL WILL BE ON THE LEFT.
