FROM OAK AIRPORT TO HOTEL:	TAKE I-880 NORTH FOR 10 MILES. TAKE EXIT 46B ONTO I-80 EAST/I-580 WEST TOWARDS SAN RAFAEL/SACRAMENTO FOR 38 MILES. TAKE EXIT 45 ONTO TRAVIS BLVD, KEEP LEFT ON TRAVIS BLVD WEST FOR .5 MILES, TURN LEFT ONTO HOLIDAY LANE, SLIGHT LEFT, HOTEL ON THE RIGHT
FROM SFO AIRPORT TO HOTEL:	TAKE 101 NORTH TOWARDS SAN FRANCISCO FOR 11 MILES. TAKE EXIT 433 B ON THE RIGHT ONTO I-80 EAST TOWARDS BAY BRIDGE FOR 45 MILES. TAKE EXIT 45 ONTO TRAVIS BLVD WEST FOR .5 MILES, TURN LEFT ONTO HOLIDAY LANE, SLIGHT LEFT, HOTEL IS ON THE RIGHT (\$5 TOLL REQUIRED).
FROM SAC AIRPORT TO HOTEL:	TAKE I-5 NORTH TOWARDS REDDING FOR 8.3 MILES. TAKE EXIT 537 ONTO MAIN ST. TOWARDS WOODLAND ON CA-113 DAVIS, FOR 36 MILES (CA-113 WILL MERGE WITH I-80 WEST). TAKE EXIT 45 AND TURN RIGHT ONTO TRAVIS BLVD FOR 300 FEET AND THEN LEFT ONTO HOLIDAY LANE SLIGHT LEFT, HOTEL IS ON THE RIGHT.
FROM SITE TO HOTEL:	RIGHT ONTO SUISUN VALLEY RD FOR .5 MILES. RIGHT ONTO ROCKVILLE RD FOR 1.7 MILES, TAKE SECOND EXIT AT ROUNDABOUT (SO THAT YOU CONTINUE ON ROCKVILLE RD) FOR ONE MORE MILE. TURN LEFT ONTO OLIVER RD AND .3 MILES LATER, LEFT AGAIN TO STAY ON OLIVER ROAD. NEXT RIGHT IS HOLIDAY LANE FOR .2 MILES, HOTEL IS ON THE RIGHT
