REGISTRATION DEADLINES

- Captains must register by **Monday, March 3rd, 2025**. Captain Registration Fee: \$12.00. Captains use the Captain Team Number for your level of play to register the team.
- Mail \$120 deposit check to your level Coordinator - check payable to USTA HOA. **Deposit checks will be destroyed at the end of the season if your team has no defaults or provides clubs with 24-hour notification in the event you need to default a court.**
- When registration closes and your deposit check is received by the level Coordinator, you will receive your “official team number”.
- Teams must have 40% of their players at level and no more than 2 out of district players.**
- Player fee is \$42.00 + Tennislink fee
- A majority of team members should be registered by Monday March 17th. Players may be added to

the roster up to two weeks before the final regularly scheduled match.

7. Players **MUST BE REGISTERED PRIOR** to the start of their first match to avoid a default.

USTA MEMBERSHIP

All players must be current members of the USTA and registered on TennisLink. The membership must be current through August 2025

NTRP RATING

- 2024 Year-end Ratings are available on TennisLink. Simply click on “Find A Rating”.
- A player may play in more than one NTRP level during the same season.
- Any player without a valid computer rating may “self-rate” on TennisLink.

COURT COSTS & BALLS

NO court fees for players. All court costs will be paid directly to the clubs by USTA Heart of America. **The Home team is responsible for providing balls.**
