Below is a sampling of committees, task forces and project teams the organization has had, Note that these are subject to change.

- 1. **USTA League** oversee the policy and development of the USTA League program and consults with organizational staff on plans & initiatives to grow league play, especially within new and diverse markets. They ensure rules and regulations are adopted in a way that supports an environment of fair play and good sports.
- 2. **NTRP** will review and render decisions regarding NTRP Appeals, Medical Appeals & NTRP Grievances for the Section in accordance with National and Section policies & procedures. Note: a strong understanding of the National Tennis Rating Program and levels of play in tennis is preferred.
- 3. Central League Grievance will work in collaboration with the Section and USTA League stakeholders to evaluate, and decide matters related to the USTA New England League program and standards of conduct, fair play, and good sportsmanship in the game of tennis. The Central League Grievance Committee has the general responsibilities in accordance with policies and procedures (e.g. Rule, or Regulations) approved by the USTA National and Section Board of Directors.
- 4. Grievance will work in collaboration with the Section, USTA National Grievance Committee, and tennis industry stakeholders to evaluate, and decide matters related to the USTA New England Constitution, Bylaws, USTA Section and National Regulations and standards of conduct, fair play, and good sportsmanship in the game of tennis. The Grievance Committee has the general responsibilities in accordance with policies and procedures (e.g. Rule, or Regulations) approved by the USTA National and Section Board of Directors.
- 5. Wheelchair & Adaptive will collaborate with the USTA New England Section Staff, State Associations, and community stakeholders to promote, develop, and support inclusive tennis programs and initiatives for individuals with differing abilities (physical, developmental, mental, and/or environmental challenges). The Wheelchair & Adaptive Committee will create pathways to play opportunities throughout the New England community.
- 6. Diversity, Equity & Inclusion will collaborate with the USTA New England Staff, State Associations, and community stakeholders to promote and develop pathways of inclusion to our sport throughout New England. The DEI Committee will engage in activities aligned to the USTA New England mission of making our sport accessible to everyone.
- 7. **Junior Competition** To support a structure of competition that helps to improve tournament quality by helping to discuss ways in which tournaments can improve

- through the USTA New England Regulations. To provide recommendations to continually improve junior programs and events for all players in the Section.
- 8. **Officials** The Officials Committee is responsible for the certification process of all officials within USTA New England as outlined in USTA policies. The committee serves in an advisory capacity for staff regarding opportunities and initiatives to promote the USTA Officiating Program.
- 9. Awards The Awards Committee honors individuals and organizations that contribute to and serve the game of tennis in a meaningful fashion that positions tennis as a model sport in society. The Awards Committee updates and improves awards, recognition and processes for all USTA New England Section Awards and recommends nominees from the Section for USTA National Awards. The Committee members are expected to submit nominations for various awards and drive nominations within the community. The Awards Committee serves in an advisory role to State Associations in any local awards and recognition programs as appropriate.
- 10. **Hall of Fame** is entrusted with the responsibility of promoting, reviewing applications and selecting individuals who have made significant contributions to tennis in the New England region for induction into the USTA New England Hall of Fame. The USTA New England Hall of Fame Task Force plays a vital role in preserving and celebrating the rich history of tennis in the region.
- 11. **Good Sport** to improve ethical conduct in all aspects of USTA Junior Tennis in New England. The Committee will help foster the core values of fair play, respect, civility, honesty, and personal responsibility among all competitors, parents, coaches, spectators and officials
- 12. **Coaches Commission** To create a network of coaches in the section that promote the player development pathway by supporting the Early Development Camps structure and identifying players that are strong candidates for the Team USA Sectional and Regional Camps that will help train a continuous wave of fundamentally sound 8-14 year old's in alignment with the USTA teaching and coaching philosophy.
- 13. **National Selection** To ensure the best players represent USTA New England in USTA National Junior Competitions and that players selected exhibit the core values of fair play, respect, civility, honesty, and personal responsibility among all competitors, parents, coaches, spectators and officials.
- 14. **Youth Play -** provide recommendations to continually improve junior programs and events such as Junior Circuit events, and Team play to include Team League, for all players in the Section. The committee will provide feedback on the junior pathway, match play, player health, sportsmanship, growing the game, and rules and regulations.

- 15. **Adult Competition** promotes, advises, evaluates and makes recommendations on recreational and competitive tournament play opportunities for players 18 and over in age, rating, team, and family division events.
- 16. Adult Social To grow USTA New England Social Leagues around New England, build infrastructure to support that growth and provide feedback based on observations and experiences at our existing league.
- 17. **Public Relations** To assist the Marketing staff in their responsibility to maintain a positive image of the organization in the community by assisting with and monitoring public relations and publicity activities.
