



HOW TO QUALIFY FOR THE 2021 NTRP NATIONAL CHAMPIONSHIPS FROM THE NORTHERN CALIFORNIA SECTION

Divisions:

- 18 & Over Men's & Women's 3.0, 3.5, 4.0, 4.5, 5.0 Singles/Doubles
- 50 & Over Men's & Women's 3.0, 3.5, 4.0, 4.5 Singles/Doubles

Northern California's quota for 2021:

Northern California's quota is 4 players in each singles division, and 4 teams in each doubles division.

- 2 of the quota spots will be reserved for the 2019 endorsed players listed below that did not get to play in the 2020 NTRP National Championships due to the tournament being cancelled
- Players for all remaining quota spots will be selected using the following criteria

Selection Criteria:

- 1) The determined placements of the 18 & Over and 50 & Over NorCal NTRP National Qualifying Tournament in the division they played.
- 2) Spots not filled by the determined placements of the 18 & Over and 50 & Over NorCal NTRP National Qualifying Tournament will be determined using the 2020 USTA NorCal Final Ranking list. Should a tie exist in determining the endorsed positions for the NTRP National Championship tournaments, the following criteria will be used, in order, until the tie is broken: head-to-head matches won; most tournaments played; most matches played; coin toss.
- 3) After using the USTA NorCal Final Ranking list, any remaining spots will be determined by the Adult Tournament Committee.

* Doubles selections for the NTRP National Championships are team based.

USTA National can accept additional players beyond NorCal's quota at their discretion. Please contact adulttournaments@usta.com with further questions.

NTRP Rating Validation:

- Player will use his/her year-end rating the year prior to the NTRP National Championship
- Self-rates are not eligible to participate

Player's Responsibility in National NTRP Championships:
