



## Unanimous Written Consent of the USTA NorCal Governance & Ombuds Committee

The undersigned, being all the members of the USTA NorCal Governance & Ombuds Committee, hereby unanimously consent as follows:

### **Sanctioning Process for 2021 Ranking Tournaments**

**RESOLVED:** That, effective immediately:

- For the sanctioning of 2021 ranking tournaments only, the provisions of USTA NorCal Sanction Rule 5.D., which requires sanction approvals to be made by the Sanction & Schedule Committee and gives denied applicants the opportunity to appeal a sanction decision to the USTA NorCal Board will be set aside; and
- For 2021 ranking tournaments the following process will be used:
  - ≈ All tournament applications will be reviewed and approved by resolution by the Sanction & Schedule Committee.
  - ≈ All approved applications will be presented to the USTA NorCal Board of Directors in the form of a Committee Decision or an Action Item for final approval.
  - ≈ When dictated by time constraints, the Executive Committee may approve the sanction applications, and such actions will be considered to have met the standard of urgency set forth in Bylaw IX.A.
