SAFEPLAY COMPLIANCE

Who needs [Safe Play](#)?

Adults who have regular contact with or authority over a minor athlete in USTA programs, events, or tournaments must be in compliance with Safe Play. This includes background screens and education about preventing misconduct in sport for the following groups:

- USTA Staff
- Coaches
- Individuals that coach voluntarily
- Section Championship Host

How do I get approved?

The Safe Play Approval process consists of the following two-step process:

Step 1

Read and acknowledge the USTA Safe Play Policy.

Complete education from the U.S. Center for SafeSport.

Step 2

Complete your background screen application.

All coaches must be certified and submitted prior to coaching during the season or section tournament.

Junior Team Tennis Season

Season Format of Play

When the coach/team manager prints out the scorecard the format is on the card. Team matches consist of:

- Two singles sets: one boys, one girls
- Two doubles sets: One boys, one girls
- One mixed doubles set

Important:

Each team requires a team minimum of 3 girls and 3 boys for each match. Each gender is allowed 1 player to play UP TO two lines for each match.

We recommend local programs use a 8-game pro-set, with ad scoring format with a 7-point tiebreak at 7-7. The winning team will be determined by total games won. *Shortened formats may be used if agreed upon prior to the start of the match, starting at 2-2, for example.*

Note: *The Section Championship will use an 8-game pro-set, no-ad scoring format with a 7-point tiebreak at 5-all. The tournament director reserves the right to alter this scoring format, if needed.*

***scoring format subject to change**

Season Schedule

All scheduled league team registrations will open on April 2nd, 2026 and close May 29th, 2026.

Admin-Only team registration opens April 2nd, 2026 and ends June 10th, 2026.

- *If admin-only teams choose to take part in (Tennislink) recorded single day JTT events or self-scheduled matches, the teams must be registered by individual registration deadlines or before the self-scheduled match.*

All scheduled seasons play from the week of June 7th, 2026 through the week of July 12th, 2026.

- BYE weeks must be requested in the registration form.

Division Levels

18U Advanced:

18U Advanced is made up of competitive high school players who advance during the high school season, compete in Level 4+ USTA tournaments, plan to take their game to the next level, or just want to compete with some of the best JTT players in Northern.

- Recommended WTN Greater than 33 (example: 24-33)
- Recommended Age: 14 years old and up (9th grade or older)
- **Season Matches + Section Championship Eligible**

18U Intermediate:

18U Intermediate is a broader division that will be broken up into 2 levels in 2026. Level

descriptions are below:

- Level I (One):
 - This division will play bi-weekly doubleheaders. Level I (One) players can range between beginner to lower junior varsity. Players that are developing their court skills and learning the rules/techniques of tennis.
 - Recommended WTN Less than 37 (example: 37 to 40) or does not have a WTN rating
 - Recommended Age: 11-18 years old (7th - 12th grade)
 - **Season Matches + Freezie Cup**
- Level II (Two):
 - This division is composed of players that are junior varsity to lower-varsity players. Although they are developing athletes, they are only a few steps away from leveling up to advanced.
 - Recommended WTN Less than 32 (example: 32 to 38)
 - Typical Age Range: 13-18 years old (8th -12th grade)
 - **Season Matches + Section Championship Eligible**

14U Intermediate:

14U Intermediate is a division for the developing 11-14 year old player wanting match play experience. This level of play is great for players that are a step up from beginner.

- Recommended WTN Less than 32 (example: 32 to 40)
- If a player that is 10 and under would like to play in a yellow ball league, they must meet [Play Tracker](#) pathway requirements.
- **Season Matches + Section Championship Eligible**

12U Intermediate Green Ball:

12U Green Ball is designed for players going through the [Net Generation PlayTracker](#) point pathway or are age eligible beginners.

- This division will play bi-weekly doubleheaders.
- Players aged 9-11 years old are recommended to play in green ball programs.
- All players in green ball will be required to meet 1500 points on the PlayTracker in order to play in yellow ball events. At least 1000 of these points must come from win points. At age 11 players will age out of the PlayTracker.
- Not WTN based - beginner to intermediate level
- **Season Matches + Freezie Cup**

Players must register for their team on [TennisLink](#) prior to their first match and no later than July 10th, 2026. It is highly encouraged to have your players play in more than one match to get the full experience.

Section Championship team registration opens June 22nd, 2026 and closes July 7th, 2026. *There are no refunds on registrations.*

Alternative option available:

Admin-Only includes Administrative Services only.

- To be considered an Admin-Only team, the program must be located outside a 50 mile radius of the section office. 2685 Vikings Cir Suite 100 , Eagan, MN 55121
- Teams that do not require section office scheduling must still communicate their days of play so they can be recorded into TennisLink.
- Teams outside of the 50 Mile radius can choose to be included in the scheduling, but travel will be necessary for weekly matches. Teams that are included in the section scheduling will be charged the standard league fee for registration.

[USTA Junior Membership: Free](#)

TennisLink Player Registration Fee: \$3.15 per player (this fee is set and goes directly to Active, the company that created TennisLink). Bulk adding players is available, but the fee still applies.

Team Eligibility

All teams must participate in at least 3 scheduled matches by July 10th, 2026 to be eligible to register for the Section Championship. ALL scheduled matches **must** be recorded in Tennis Link. ALL matches **must** meet the team minimum requirement. *Exception: Admin-Only league teams.*

Scorecard Policy

It is strictly prohibited for any coach, manager, or designated team representative to enter scores for a JTT match where a player listed on the team roster did not physically participate in a minimum of one point within that specific team match.

Player Eligibility (Singles WTN)

- Players must remain age-eligible from May 29th, 2026 through July 31, 2026 in order to register and participate in Junior Team Tennis. *For example, a player turning 15 during the eligibility period, should play on a 18U team to start the season.*
- All players with the following World Tennis Number high confidence ratings **MUST** play in their respective levels.

The [ITF World Tennis Number](#) provides a global standard for players. It is a 40-1 scale, with 40 being a beginner player and 1 being an elite professional. This scale is for all players, regardless of age, gender, or ability. Players will have separate ITF World Tennis Numbers for singles and doubles. Not all players have a WTN, so it is up to the coaches and parents to use their best judgment on level designation.

If players have a medium (light blue) to confident (dark blue) WTN rating, it is recommended to be within the WTN range at point of registration.

- 12U Green Ball:
 - not WTN based - beginner to intermediate level

- 14U Intermediate:
 - WTN Less than 32 (ex. 32 to 40)
- 18U Intermediate Level One:
 - WTN Less than 37 (ex. 37 to 40)
- 18U Intermediate Level Two:
 - WTN Less than 32 (ex. 32 to 38)
- 18U Advanced:
 - WTN Greater than 33 (ex. 24 to 33)

Local Match Procedures

What if a team doesn't have the required number of players for a local match (3 boys and 3 girls)?

- If a team is unexpectedly short players for the match, the coach/team manager should contact the opposing team to let them know 24-48 hours in advance. In the case of the minimum player requirement not being met, a line of singles or doubles is required to be recorded as a default for the respective team.
- One player of each gender can play up to two lines and all other lines should be counted as a default if the minimum requirement is not met. If a team has less than 2 boys and or 2 girls, please follow rescheduling procedures.
- Please communicate with the opposing team at the beginning of the season to avoid last minute cancellations due to player shortage or travel conflicts.

What time do matches usually start (Metro MN League)?

- Suggested match times are below, however, coaches may agree upon match times of their choosing prior to the start. Coaches may also add and/or adjust the days/times of their matches if needed, so long as both coaches are in agreement.
- Please communicate with the opposing team at the beginning of the season for any known conflicts.
- **Some programs cannot start until 1:30pm, please note that some matches may be scheduled later than 1:00pm.**
 - **14U Intermediate on Tuesdays : 1:00 PM - 4:00 PM**
 - **12U and 18U Intermediate One on Wednesdays : 1:00 PM - 5:00 PM**
 - **18U Advanced and 18U Intermediate Two on Thursdays : 1:00 PM - 4:00 PM**

Schedule Commitment

Team providers are responsible for communicating with their players the high expectation of attending matches and or practices. Respecting your weekly opponent's time is extremely important. Defaulting matches due to the lack of prompt communication may result in team disqualification from the Section Championships. Please keep communication and commitment to the schedule as a top priority. If a team is unexpectedly short players for the match, the coach/team manager should contact the opposing team to let them know at least 24-48 hours in advance.

Refund Policy

Teams that withdraw before a deadline will receive a refund minus the non-refundable TennisLink player and Square processing fees. **Teams are not eligible for refunds after entry deadlines.** ***If you are unsure of how many teams you will have, please only register what player capacity you can fill. Extra season teams can be added if you acquire more players no later than May 29th, 2026. Additional sectional teams will not be accepted after the July 7th, 2026 deadline.***

The platform we go through for payment (Square and Stripe) have changed their refund policy. As of May 17th, 2023: If a team withdraws during the eligible time frame, 3% of the amount being refunded will be deducted to cover the processing fee incurred.

What do I do for _____?

Check in

We recommend arriving 30 minutes ahead of the scheduled time. Line-ups will be exchanged and court assignments will then be given out.

Rescheduling

Metro MN, Southeast MN Northland MN, and Iron Range MN leagues scheduling will be dual based, and rescheduling will be between the opposing coaches. Once you reschedule, please notify Natalie in the Northern section office at natalie@northern.usta.com to let her know the new date the match will be played. Your match will then be adjusted in TennisLink.

Line-Ups

Coach/Team Managers in all divisions are highly encouraged to communicate their team's "order of strength" prior to the match to allow for the best match ups between players. Players who are not registered on that team in TennisLink may play matches; however, their results will be recorded as defaults. We encourage players to be registered before their first match at the beginning of the season to avoid this conflict.

Order of Matches

If a player is scheduled for more than one match in a single lineup (example: singles & mixed), we recommend that those players play first in order to minimize any potential delays.

Coaching

Coaching is allowed only on changeovers and is limited to 90 seconds. Coaching is allowed after the first game, but it must be kept short and cannot be a disruption to the flow of the match. No coaching is allowed during a tie-break.

Rain

If you think there may be rain, please connect with the coaches involved. Decisions related to playable courts are the host facility's responsibility. Follow rescheduling procedures if needed.

Air Quality Index (See your area in real time [HERE](#), via airnow.gov)

Local Program Expectations

Local program expectations are in place to ensure that a high quality program is administered by all involved, and that those who violate our expectations are held accountable. It is recognized that emergencies do occur. If a coach or team manager is notified in a timely manner by the opposing coach of a situation, they should be flexible and try to accommodate the other team.

- All coaches MUST be USTA Safe Play approved. For more information, please click here: <https://www.usta.com/en/home/safe-play.html>
- Teams shall be knowledgeable of the program rules & regulations and adhere to them.
- The coach or team manager is responsible for holding their players accountable to play and act in accordance with the Rules of Tennis and The Code as outlined in the Friend At Court.
- Coaches, players, and spectators are expected to display good sportsmanship and treat all players, coaches, and others in attendance with respect at every match.
- USTA Northern expects the local program match environment to be free of drugs, tobacco and alcohol.
- Teams MUST register all of the players participating in local program matches in TennisLink PRIOR to their first match. Players not listed in Tennis Link are ineligible to play.
- The local match scores are expected to be recorded in TennisLink within 24-48 hours of completion of a team match. It is the expectation that whichever team is listed as the Home Team will submit the scores.
- Once a team registers in TennisLink and commits to a local program schedule, they are expected to honor that commitment and bring at least six {6} players (3 boys and 3 girls) to every scheduled match.
- Teams shall make an attempt to reschedule all local program matches that were not able to be played on the original date.
- Teams are expected to have at least three (3) courts available for every home dual match.

- Exhibition matches are encouraged, but not required as it will not count towards the team score. Exhibition matches must be determined prior to the start of the dual match.
- USTA Northern has a zero-tolerance policy for unacceptable spectator and player behavior, which can lead to immediate removal from the premises, and for spectators, a suspension of their ability to attend future events. This policy is in effect to uphold good sportsmanship and fair play.

Registering a JTT team serves as confirmation that every Coach or Team Manager has read and understands and agrees to follow the rules, policies, and expectations for the USTA Northern Junior Team Tennis (JTT) 2026 Season and Section Championships Regulations. **This document is only a summary of the 2026 USTA Northern JTT Regulations.**

1. Safe Play Compliance (Mandatory for Coaches/Managers)

*I acknowledge and affirm my understanding of the [Safe Play Compliance](#) requirements and certify that, if I am an adult who has regular contact with or authority over a minor athlete, I must:

- **Read and Acknowledge** the USTA Safe Play Policy.
- **Complete** education from the U.S. Center for SafeSport.
- **Complete** my background screen application.

*I understand that proof of Safe Play compliance will be required prior to the Section Championship desk to receive a daily wristband (required in order to coach in any capacity).

2. Season Team and Player Management Responsibilities

*I acknowledge and agree to take full responsibility for the following team and player logistics:

- **Team Minimums:** I will ensure the team meets the minimum requirement of **3 girls and 3 boys** for each season match. I understand that each gender is allowed 1 player to play up to two lines per match.
- **Player Registration:** I am responsible for ensuring **ALL players** participating in local program matches are registered for the team on **TennisLink prior to their first match** and no later than **July 10th, 2026**. Players not listed in TennisLink are ineligible to play and their results will be recorded as defaults.

3. Schedule Commitment and Communication

*I acknowledge and agree to adhere to the highest standards of schedule commitment and communication:

- **Local Match Procedures:** I will exchange line-ups and am highly encouraged to communicate the team's "order of strength" prior to the match. WHAT IS JUNIOR TEAM TENNIS?

USTA Junior Team Tennis (JTT) brings together boys and girls, ages 11-18, to play singles, doubles and mixed doubles against other coed teams. Beyond being fun and a great form of exercise, Junior Team Tennis is a competitive, level-based environment that promotes individual growth, social growth and life skills.

Junior Team Tennis emphasizes sportsmanship — that success isn't just about winning, it's about how you play the game and respond to challenges. JTT also teaches kids how to work together for success. Nearly 100,000 kids nationwide play Junior Team Tennis annually, thanks to the many volunteers that can include coaches, tennis professionals and player parents who often serve as team managers and captains.

USTA Northern currently offers leagues and scheduling for 12 and under green ball, 14 and under intermediate, and 18 and under intermediate/advanced divisions. The summer season runs June to July, starting with weekly matches and ending with the section championship tournament.

18U Advanced:

18U Advanced is made up of competitive high school players who advance during the high school season, compete in Level 4+ USTA tournaments, plan to take their game to the next level, or just want to compete with some of the best JTT players in Northern.

- **Season Matches + Section Championship Eligible**

18U Intermediate:

18U Intermediate is a broader division that will be broken up into 2 levels in 2026. Level descriptions are below:

- Level I (One):
 - **This division will play bi-weekly doubleheaders.** Level I (One) players can range between beginner to lower junior varsity. Players that are developing their court skills and learning the rules/techniques of tennis.
 - Recommended WTN Less than 35 (example: 35 to 40) or does not have a WTN rating
 - Recommended Age: 11-18 years old (7th - 12th grade)
 - **Season Matches + Freezie Cup Eligible**
- Level II (Two):
 - This division is composed of players that are junior varsity to lower-varsity players. Although they are developing athletes, they are only a few steps away from leveling up to advanced.
 - Recommended WTN Less than 29 (example: 29 to 34)
 - Typical Age Range: 13-18 years old (8th -12th grade)
 - **Season Matches + Section Championship Eligible**

14U Intermediate:

14U Intermediate is a division for the developing 11-14 year old player wanting match play experience. This level of play is great for players that are a step up from beginner.

Communication Expectations

Local Section Coordinator

Ultimately, the primary responsibilities of the local league coordinator are to serve as the main decision maker and ensure that every child in the league has an enjoyable and rewarding experience. The coordinator will schedule the season matches and oversee the section championships.

They are the main communicator with coaches and team providers. While email is the main form of contact, the coordinator and providers should also make phone numbers available. This can make last-minute communication easier to provide.

Coach and Team Captains

Coaches and captains are in charge of their own team, and will communicate with players and parents directly. Coaches and team managers are required to register their own players online after receiving their team ID from the section coordinator.

Teams should have practices in between matches to get them ready to play their best, just like in any other sport. Teams can either set a date and time each week or vary it. Practice plans are up to each coach and will depend on the age and skill level. When organizing a practice, coaches should be sure that courts and equipment are available to use. There are a variety of resources for organizing practices, including the Net Generation App.

At a team match, one adult should be in charge of each team. A few days before the match, opposing coaches should contact each other to review the date, time, location and how many players each team will have. **If a team has short players, the coach should let the other coach know so that the other team will know how many players to bring, or whether a player will need to play twice. If the coach knows they will not be able to field a full roster ahead of time, reach out to the opposing coach as soon as possible to try to reschedule.**

The coach should also communicate with his/her team before each match, letting them know what they are playing and if there are any time constraints. Players and parents should know to contact the coach by phone or text if there are any last-minute changes. Another important item to communicate is the level of players to be able to provide the best level-based play.

When players arrive, a coach should take attendance of who is there. A coach should also have a contact list, should a player not show up, so lineups can be adjusted. Match assignments can then be determined, with the goal to get out as many matches as possible so players are not waiting around too long.

Before play begins, coaches should bring all the players together to discuss rules and any housekeeping items (bathrooms, trash on court, etc.).

After matches are done, coaches should write all scores down and confirm with the opposing coach. The scores should then be entered into TennisLink by the coaches no more than 48 hours after the match. Coaches should also send a summary to their teams.

Communication is one of the best parts of being a coach. The coach has to communicate with parents, players, other coaches and the local coordinator. A coach should have contact information that includes email and mobile phone for all parties. If team providers have more than one coach, it is expected that all contact information is given to the coordinator. This includes names, email addresses, and phone numbers.

Score Entry

Team managers/coaches are responsible for entering scores, preferably within 24 hours of match completion, but no more than 48 hours. This typically falls on the home team captain, although either captain can enter scores.

Weather Updates

A rainout match day should be designated at the beginning of the season. Coaches are then responsible for scheduling any rainout matches that occur throughout the season.

Managing Conflicts

Conflicts may arise throughout the season. These could include inappropriate coaching by a parent to their child, other parents becoming upset about line calls/incorrect scoring, lack of spectator etiquette, etc.

["Friend at Court"](#) can be a good reference. The Section Coordinator lists what USTA Northern's process is in the League Regulations, but coaches can contact the league coordinator for guidance.

Insurance

If facilities or programs wish to be insured, they must contact their local insurance agent. USTA Northern does not insure coaches or providers. USTA Coaching does offer an option for insurance, please [click here](#) to learn more on the website.

Schedule Commitment

Team providers are responsible for communicating with their players the high expectation of attending matches and or practices. Respecting your weekly opponent's time is extremely important. Defaulting matches due to the lack of prompt communication may cause team disqualification from the Section Championships. Please keep communication and commitment to the schedule as a top priority. If a team is unexpectedly short players for the match, the coach/team manager should contact the opposing team to let them know 24-48 hours in advance.

SAFEPLAY COMPLIANCE

Who needs [Safe Play](#)?

Adults who have regular contact with or authority over a minor athlete in USTA programs, events, or tournaments must be in compliance with Safe Play. This includes background screens and education about preventing misconduct in sport for the following groups:

- USTA Staff
- Coaches
- Volunteers
- Section Championship Host

FRIEND AT COURT

THE HANDBOOK of TENNIS RULES and REGULATIONS (2025 Edition)

[Friend at Court](#) is the book of rules and regulations under which tennis is played in the United States. It is recommended reading for players, parents, coaches, teachers, tournament directors, league officials, and anyone who wants a finer understanding of the

game. A working knowledge of the ITF Rules of Tennis, *The Code*, and USTA Regulations is essential to playing the game the way it should be played.

PRESEASON PLANNING

Budgeting

There is a lot that goes into running a successful junior team tennis program. Items such as court costs, balls, USTA Northern team fees, TennisLink system player fees, and other expenses can be often overlooked.

Providers can choose to charge the amount they feel necessary, but USTA Northern encourages programs to make the cost to play accessible for all players. The goal for a program should be to benefit the player's experience at an affordable cost.

Note: Some coaches in our section choose to volunteer their time. This reduces the expenses dramatically, but is not expected.

Sample Budget:

This would be a sample budget for a program that covers the player fee through Tennislink and is scheduled through the office. The USTA Northern Fees are based on 2026 regulations.

The \$15.57/hr wage is based on minimum wage in the Twin Cities, MN. Please pay your coaching staff appropriately - this is just an example.

Sportsmanship Prizes or Shirts	\$10/player = \$320
A bare minimum example*: Season Coach Costs \$16/hr ~32 hours (~15 hrs matches) + (~10 hrs practices) + (~7 hrs section championship) = \$512 + \$120 in travel - This is a sample for a multiple coach payroll and 5 week season	\$632 per coach (3 coaches) = \$1,896
Total Expenses	3,396.80
Gross Profit	\$443.20

The profit from the season can go towards outstanding expenses OR towards an end of season party. An example would be a pizza or ice cream party at a park.

Sponsorships and Grants

JTT teams may also solicit revenue from outside sources such as sponsorships, grants and support from organizations in the USTA family. Sponsorships may be used to provide amenities to players, for example, T-shirts or a player party at the end of the season.

Grants are normally provided as a means of reducing costs for leagues in more economically challenged areas. If the coach or team captain is applying for grants, they should be focused on providing information on the benefits of playing tennis to the participant and emphasizing these benefits to the foundation or nonprofit organization to which they are applying. The USTA and their sections do give out grants to programs, but there are many other places that do also, such as nonprofits and foundations in the area.

Junior Scholarships- 2026

USTA Northern budgets annually for travel reimbursement to attend the Section Championships. Please contact your local coordinator to see if this information is available. *Available to counties outside teams outside of the Metro MN League County Radius (or 51 Miles from the section office).*

RECRUITING

Coaches

Coaches can be club pros, school coaches (although some districts have restrictions on this), recreation department employees, avid tennis players, or parents. Parents can be great coaches if well trained, and there are a number of places that they can go to be trained.

Consider having an informational meeting for individuals interested in coaching. Make sure league logistics are set prior to the meeting: locations, season dates, match days and league regulations. A well-organized meeting can help potential volunteers see the value in assisting with the league.

Players

Once coaches are identified, they can begin recruiting players. While it can be simpler to recruit players they know, they should be encouraged to work on reaching out to the wider community. To find new players, school handouts can be created to go home to parents of younger players, notices can be added in school newsletters and posters can be created to hang up at schools, among other ideas. The USTA has many different marketing materials available. Contact your [USTA Northern Manager](#) for more information.

For programs that involve players already participating in lessons or clinic programs, e-blasts or handouts are great. Club pros can be encouraged to have JTT in-house parties that can also act as recruitment tools while providing play for their members and education for the parents.

Marketing and Promotion

There are many different ways to promote JTT:

- Social Media: Instagram, X (Twitter), Facebook, etc.
- Paper Flyers & Posters
- Email Campaigns & Newsletters
- Relationship Building with Clubs & Pros

Communication

Communication is extremely important in coordinating a JTT Program. Emails and texts are a key component of this communication. An outline of in person/virtual meetings is found below:

- **Introductory Meeting or Email:** Include all coaches and cover season dates, player eligibility, level of play, costs, registration instructions, TennisLink, league rules, SafePlay background screenings, etc.
- **One-on-One Meetings with New Coaches:** Can go into more detail on the league procedures, [TennisLink](#) and [Net Generation](#).
- **In-Season Meetings or Conference Calls:** Work out any issues that may arise with players, parents, weather, etc.
- **Parent Meetings:** Review expectations for parents, including conduct, sportsmanship, etc., and be sure to host prior to the beginning of the league.

WRAP-UP

At the end of the summer season, the league coordinator will reach out to the coaches with the following items to wrap up:

- Confirm score entry
- Section Championships results
- End-of-year coach survey
- Upcoming events

The coach survey will aid in the next year's revisions.

Coaches should end the season by wrapping up communication with their parents and players and also encourage any eligible players to return for next year's season.

Piloting a Scheduled (Outer-Metro) League

If a program is wanting a scheduled league for their area (outside the 50 mile radius), please contact the section league coordinator.
