



To the Parents of all USTA Texas Super Champ Level Players:

The Junior Competitive Tennis Council has mandated that all Super Champ level players must have a Xerox copy of an original Birth Certificate or a photocopy of a Passport and/or Permanent Resident card on file with the Texas Section office in order to compete at the Super Champ Designated Tournaments. Super Champ players will not be allowed to play a 2019 Super Champ Designated Tournament if their certified Birth Certificate is not on file by the entry deadline with the exception of newly qualified players from Champs. Championship Level players may submit the required documents at any time, but must have the required documents on file within 2 months after qualifying for the Super Championship level (i.e. Qualify for Supers in Jan 2019- must have on file by Apr SCMZ deadline) They may play the SCMZ during these two months, but will not be allowed to play after the 2 months until required documents are not submitted. **Required documents only need to be submitted once – they do not need to be re-submitted for a player that re-qualifies and has previously submitted documents.**

If the players' Birth Certificate is from a foreign country, the player must also submit a copy of their Permanent Resident Card, commonly called the "Green Card". If a foreign born player does not have a Permanent Resident Card, they may submit a copy of their Birth Certificate or Passport, along with any applicable Visas.

Once submitted, these documents will be used to verify USTA eligibility rules associated with receiving National Ranking points due to participating in a SCMZ, as well as eligibility requirements for Endorsement for National Level 1 tournaments from the Texas Section.

All Out of Section players who are approved to play at the Super Champ level are also required to submit a certified copy Birth Certificate (or photocopy) at this time.

All Super Champ level players, Texas residents or approved Out of Section players who have submitted a certified copy of a Birth Certificate are eligible for Texas Section Ranking points.

Certified Birth Certificates or photocopies must be mailed, as faxed or emailed copies will NOT be accepted.
