

SWEEPSTAKES OFFICIAL RULES
2025 WORLD’S HEALTHIEST SPORT Sweepstakes

OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND D.C. (EXCLUDING PUERTO RICO, GUAM, THE U.S. VIRGIN ISLANDS AND OTHER U.S. TERRITORIES), WHO ARE AT THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE (18 YEARS OF AGE IN MOST STATES, 19 IN ALABAMA AND NEBRASKA, 21 IN MISSISSIPPI). NO ENTRY FEE NECESSARY TO ENTER. VOID WHERE PROHIBITED BY LAW.

AS DESCRIBED BELOW, THESE RULES REQUIRE THAT DISPUTES BE RESOLVED ON AN INDIVIDUAL BASIS, RATHER THAN BY CLASS ACTION AND LIMIT YOUR RIGHTS AND REMEDIES IN THE EVENT OF A DISPUTE.

The United States Tennis Association Incorporated (“*USTA*” or “*Sponsor*”) is sponsoring the 2025 World’s Healthiest Sport Sweepstakes (the “*Sweepstakes*”) as described below.

Each participant entering the Sweepstakes (each a “*Participant*”) agrees to be bound by these Official Rules and the decisions of the Sponsor, which are binding and final on all matters relating to this Sweepstakes. Winning a Prize is contingent upon fulfilling all requirements set forth in these Official Rules. USTA reserves the right to disqualify from this Sweepstakes any person it believes has intentionally violated these Official Rules.

The Sweepstakes entry period begins on November 8, 2025 at 12:00:01 AM Eastern Time (“*ET*”) and ends on December 16, 2025 at 11:59:59 PM ET (the “*Entry Period*”).

SPONSOR. The Sponsor of the Sweepstakes is United States Tennis Association Incorporated, 2500 Westchester Avenue, Suite 411, Purchase, New York 10577 (“*USTA*” or “*Sponsor*”).

HOW TO ENTER. There is no purchase necessary to participate. You may enter this Sweepstakes only once.

Method of Entry: To receive one (1) entry (“*Entry*”) in the random drawing(s) for the Prizes (as defined below), you must complete each of the following eligibility requirements by the conclusion of the Entry Period (the “*Requirements*”):

- (1) Sweepstakes Entry Form. To enter, you must complete and submit the online entry form and marketing opt-in for the Sweepstakes located at <https://www.usta.com/en/home/play/worlds-healthiest-sport/indian-wells-2026.html> during the Entry Period.

Limit one (1) Sweepstakes Entry per person. No other method of entry will be accepted. Entrance into the Sweepstakes through multiple email accounts or USTA Accounts by the same individual will disqualify Participant from the Sweepstakes. All entry materials become the property of the USTA and will not be acknowledged or returned.

If you choose to enter via your mobile device, standard data rates may apply. See your wireless provider for pricing plan details. Entries will be declared made by the authorized USTA account

holder of the e-mail address submitted at the time of entry. “Authorized account holder” is defined as the natural person assigned an account by the organization responsible for assigning the applicable email account used at the time of entry. The authorized account holder may be required to provide proof of identity. If a dispute cannot be resolved, the entry will be deemed ineligible. Any other attempted form of entry is prohibited; no automatic, programmed, robotic or similar means of entry are permitted.

DRAWING. One (1) Grand Prize Winner (the “*Grand Prize Winner*”) and ten (10) First Prize Winners, as defined herein (each a “*First Prize Winner*” and collectively, with the Grand Prize Winner, the “*Winners*”), will be selected at random by Sponsor at the conclusion of the Entry Period. The random drawing shall take place on or about December 19, 2025 by USTA or its designee, whose decisions are final and binding on all aspects of this Sweepstakes and not subject to appeal.

Selected potential Winners will be contacted by email within approximately two (2) business days after being selected. A potential Winner will be required to claim his or her prize within two (2) business days of the time the winner notification is sent.

To claim a Prize, a potential Winner must respond as directed in the email message sent to the selected Winner by Sponsor. Potential Winner will be required to provide additional information to confirm identity and eligibility and also required to complete and sign an Affidavit of Eligibility and Liability Release, a Publicity Release (where legal), a signed IRS Form W9 for tax reporting purposes, and any other documentation that USTA may require to confirm Winner’s identity, eligibility and agreement to these Official Rules. Requested documentation must be provided to USTA within two (2) business days of being requested to provide the same. In all cases, USTA reserves the right to request proof of identity, residency and age, and the potential Winner will be deemed to have forfeited the prize if USTA, in its sole discretion, finds that the proof is unsatisfactory. The Prize will be forfeited (i) if a selected potential Winner does not timely provide the requisite information, return the requisite documents or cannot be reached within two (2) business days from the initial notification attempt, (ii) if a prize is returned as non-deliverable, and/or (iii) in the event of non-compliance with any of the requirements of these Official Rules.

PRIZES. Winners will be selected for a Grand Prize and ten (10) First Prizes, as described below (each, a “*Prize*” and collectively, the “*Prizes*”).

- (1) Grand Prize. One (1) Grand Prize Winner will be selected from all eligible Entries to win the Grand Prize consisting of the following (the “*Grand Prize*”):

A trip for the Grand Prize Winner and one (1) guest to Palm Springs, California for the 2026 BNP Paribas Open. Trip includes roundtrip economy air transportation to Palm Springs, California from major airport nearest the Grand Prize Winner’s home, hotel accommodations (one room, double occupancy for two (2) nights), a Five Hundred U.S. Dollars (\$500.00) spa package gift card to a local health spa in Palm Springs, California* during your trip, and two (2) reserved lower bowl seat tickets to one (1) day session and one (1) night session during 2026 BNP Paribas Open**. Approximate retail value of the Grand Prize is Four Thousand Two Hundred U.S. Dollars (\$4,200 USD).

* Spa prize voucher/gift card is redeemable only at the designated Spa selected by Sponsor. Spa Prize redemption is subject to appointment reservation availability and may be subject to additional terms of the spa services provider.

** Dates, times and location of reserved seat tickets for the 2026 BNP Paribas Open will be determined by Sponsor in its sole discretion and may be subject to change as determined by Sponsor in its absolute sole discretion, subject to availability.

Hotel and airfare will be arranged and booked by Sponsor in its sole discretion. Airline tickets are for coach travel from major airport in the United States nearest Grand Prize Winner's home to the destination city. Travel may not be a direct flight and flight may include one or more stops. Airline carrier's regulations and conditions apply. In the event the Grand Prize Winner lives within one hundred fifty (150) miles of Palm Springs, California, Sponsor will provide the Grand Prize Winner and guest (traveling together) with round-trip ground transportation between the Grand Prize Winner's residence and Palm Springs, California in lieu of the round-trip coach air transportation from major commercial airport nearest the Grand Prize Winner's residence. The dollar value difference between the round-trip economy class air transportation and ground transportation will not be provided to the Grand Prize Winner. Trip may not be combined with any other offer and travel may not qualify for frequent flyer miles. Grand Prize Winner and guest must travel together on the same itinerary. If Grand Prize Winner chooses to bring a minor as their guest, the Grand Prize Winner must be the parent / legal guardian of minor. Guest of Grand Prize Winner (or Grand Prize Winner as a parent/legal guardian on behalf of a minor guest) as applicable, will be required to execute a Release of Liability prior to departure. All travelers must have valid travel documents prior to departure. All travel must be completed on date specified by Sponsor; dates of departure and return are subject to change. Certain restrictions and blackout dates may apply. Seat selection and timing of trip subject to availability and confirmation of reservations. All details, including exact seat locations (if applicable) and all prize components, will be determined by Sponsor in its sole discretion. Sponsor is not responsible if the event/flight is delayed, postponed or cancelled for any reason and Grand Prize Winner will not be reimbursed. Tickets/passes may be subject to issuer's standard rain-check policies and procedures. All expenses, travel, and other costs not expressly stated in the package description above are the sole responsibility of winner. Restrictions, conditions and limitations may apply. Lost, mutilated, or stolen tickets, vouchers or certificates will not be replaced.

- (2) First Prizes. Ten (10) Winners will be selected from all eligible Entries to win a First Prize consisting of: one (1) Two Hundred U.S. Dollar (\$200.00) electronic gift card for the online US Open Shop at usopenshop.org. Combined retail value of all First Prizes is Two Thousand U.S. Dollars (\$2,000.00 USD) and total ARV of all Prizes in the Sweepstakes is Six Thousand Two Hundred U.S. Dollars (\$6,200.00 USD).

Each Prize is provided "as-is." The Grand Prize Winner and his or her guest assume all risks associated with use of the Grand Prize.

Winners are responsible for reporting and paying all applicable federal, state and local taxes associated with Winners' receipt of the Prize. Sponsor will withhold and/or report taxes as required by the applicable laws of Sponsor's and the Winners' jurisdictions.

All Prizes are non-transferable and cannot be substituted, assigned, sold, transferred or redeemed for cash, in whole or in part, but Sponsor in its sole discretion may substitute a prize of equal or greater value if the Prize becomes unavailable for any reason. If a Winner cannot accept the Prize as stated, such Prize will be forfeited in its entirety and an alternate winner may be selected by Sponsor in its sole discretion.

Sponsor is not responsible if the 2026 BNP Paribas Open is rained out or postponed, or cancelled after ticketing of the Grand Prize for any reason, in whole or in part. No compensation will be paid in lieu of BNP Paribas Open ticket prizes that cannot be used for any reason, including but not limited to cancellation or postponement of the BNP Paribas Open. 2026 BNP Paribas Open ticket prizes may not be used for advertising, promotions (including contests or sweepstakes) or other trade purposes without the prior express written consent of the Sponsor. Tickets to the BNP Paribas Open are subject to all ticket terms and conditions as well as facility rules and regulations.

All Prize details shall be determined in the sole and absolute discretion of the USTA. Limit one (1) Entry and one (1) Prize per person/household.

ODDS OF WINNING. Odds of winning depend on the number of eligible entries received.

(excluding U.S. Territories), who are at the age of majority in their jurisdiction of residence (18 years of age in most states, 19 in Alabama and Nebraska and 21 in Mississippi) and have met all eligibility Requirements for an Entry set forth above. Void where prohibited by law. Employees of the United States Tennis Association Incorporated ("*USTA*"), employees of the USTA Sectional and District Associations, employees of Desert Champions LLC, and employees of each of their respective subsidiaries, affiliates, parent companies, agents, advertising and promotion agencies or any other agencies or entities involved with this Sweepstakes and any member of their respective families (parents, siblings, children, and spouse and their respective spouses) are not eligible to enter or win. Participant recognizes that nothing herein shall be interpreted to require USTA to exercise any of the rights granted hereunder.

GENERAL CONDITIONS; RELEASE. Participants agree to be bound by the terms of these Official Rules and decisions of USTA which are final and binding on all matters relating to this Sweepstakes. By participating, Participants release and hold harmless United States Tennis Association Incorporated, its Section and District Organizations, USTA National Tennis Center Incorporated, Desert Champions LLC, and each of their respective subsidiaries, affiliates, advertising and online technology agencies, prize suppliers and all others associated with the development or execution of this Sweepstakes and the directors, officers, employees or agents of any of the above organizations (collectively, the "*Releasees*") from any and all liability or any injuries, loss or damage of any kind arising from or in connection with participation in this Sweepstakes or acceptance, use, misuse or nonuse of any prize or parts thereof (including, without limitation, activity or travel related thereto), including, without limitation, liability for death,
