REGISTRATION DEADLINES

1. Captains must register by Monday, February 25
Administration Fee: \$24.00
Default Deposit: \$50.00 (check to be sent to
Level Coordinator.
Captains use the Captain Team Number listed for
your level of play to register.
2. Captains will receive their "official" team number
by Monday, March 4.
3. All players must register using their official team
number before play. Captains MUST ALSO REG-
ISTER as a player, but when they indicate they
are the Captain, the registration is FREE except
for the \$3 tennislink fee.
4. Player fee is \$27.00 + \$3.00 = \$30.00.
5. A majority of team members must register by
Monday, April 15. Players may be added to the
roster up to two weeks before the final regularly
scheduled match.

USTA MEMBERSHIP

All players must be current members of the USTA and
registered on TennisLink. The membership must be cur-
rent through July 31, 2019.

NTRP RATING

1. Current Year End Ratings for all Missouri Valley Sec-
tion players are available on Tennislink. Simply click
on "Find A Rating".
2. A player may play in more than one NTRP level dur-
ing the same season. A player may play up only one
level.
3. Any player without a valid computer rating may "self-
rate" on TennisLink.

COURT COST & BALLS

There will NOT be any court costs for players. All court
costs will be paid directly by HOA District. Home Team
provides the balls.

FORMAT

The 18 & Over League should consist of at least 10 play-
ers but not more than 18 players. All levels, except 5.0,
will play 2 Singles & 3 Doubles in each Team Match. The
5.0 Level will play 1 Singles and 2 Doubles.

Each match has a two-hour time limit including a ten-
minute warm-up. Each match is the best two out of three
sets, regular scoring. A 10-point tiebreaker, using Coman
procedures, will be played in lieu of a 3rd set.

All players must play a minimum of two matches during
the season to participate in the District playoffs and
Sectional playoffs and a minimum of three matches to
participate in the National Championships.

\$50 DEPOSIT REQUIRED

In order to ensure competitive matches with no team
defaults, a \$50 Deposit will now be required for all
teams. If a team default occurs, the \$50 deposit will be
forfeited., and a new \$50 deposit check will be required
before that team's next match. \$50 Deposit checks will
not be deposited unless a team default occurs. Please
send the \$50 Deposit to your Level Coordinator. Team
numbers will be sent to Captains after receipt of deposit
check.
