

USTA New England Community Champions Grant

Grant Description and Purpose:

The Community Champions Grant (CCG) provides up to \$15,000 to support tennis programs and providers across New England. Designed to drive growth and expand initiatives, this grant aligns with USTA New England's mission to promote the growth of tennis and inspire healthy communities throughout New England. Funding may be used for both programmatic and operational support, but only organizations with an annual operating budget of \$1 million or less are eligible to apply.

Eligibility Requirements:

- Application is **aligned with USTA New England's mission** to promote the growth of tennis and inspire healthy communities throughout New England.
- Application is closely aligned with USTA New England's Strategic Pillars. ([See more below](#)).
- Organizations seeking support must be a USTA organizational member (visit [USTA membership](#)) for more information - **membership is free**).
- All staff and volunteers working in connection with the program or initiative must be Safe Play Approved if working with youth.
- The project or initiative must impact the New England community.
- Applying entity must be an established 501(c)(3). The entity applying is permitted to work in partnership with a for-profit organization. If the applying entity is applying in partnership with a for-profit entity, a signed Memorandum of Agreement between partners is required in order to receive funding.
- Applying entity must have all prior grant accountability forms submitted before being considered for a new grant request.
- The lead organization must have an annual operating budget of \$1M or less.

USTA New England's Strategic Pillars 2024-2026:

The grant request must also align with one of the following strategic pillars:

1. Engagement

Examples:

- Successful and inclusive programming for public facilities
- Revitalizing tennis in schools
- Introducing students to team play through middle and high school tennis programming
- Player retention initiatives
- Establishing strategic partnerships
- Engaging with other complimentary racquet sports

2. People & Organizational Capacity Development

Examples:

- Coach recruitment
- Coaches training and professional development and support
- Coach mentorship and networking
- Volunteer recruitment, training, and engagement
- Partnership development
- Organizational capacity building

3. Access

Examples:

- ADA compliance, ramps, wheelchair programs, adaptive tennis (USTANE Grants Committee will support application with Tennis Venue Services)
- Tennis advocacy initiatives
- Innovative, grassroots tennis and other racquet sports

***Note:** At this time, the Community Champions Grant **does not support court maintenance and facilities projects**, however USTA New England is happy to support providers through the [USTA Tennis Venue Services](#) application process. Application Process:

- **Starting in 2025:**
 - Effective March 6, 2025, the Community Champions Grant application will remain open to applications through September 30. See specific details below.
 - Grant applications will be reviewed quarterly in a collaborative effort between the USTA New England Grants Committee and representatives from respective State Associations.
- **Anticipated review and decision dates:**
 - Summer Programming Cycle
 - Applications submitted between March 6 and March 31
 - Reviewed by April 18
 - Approval/denial letters received by May 1
 - Signed agreement and W 9 required by May 6
 - Funds disbursed by May 30, 2025
 - Indoor Programming Cycle
 - Applications submitted in Q2 (April 1 - June 30)
 - Reviewed by July 18
 - Approval/denial letters received by August 1
 - Signed agreement and W 9 required by August 6
 - Funds disbursed by August 29, 2025
 - Holiday Season Cycle
 - Applications submitted in Q3 (July 1 - September 30)
 - Reviewed in October
 - Approval/denial letters received in November
 - Signed agreement and W 9 required before funds can be disbursed
 - Funds received in November/December
 - New Year Cycle - CLOSED
 - Applications submitted in Q4 (October 1 - December 31) can only be considered for funding from respective State Associations (\$5,000 or less).
 - The USTANE Grants Committee will use this period to gather grant accountability reports and strategically plan for the upcoming grant cycles.

- **Required Application Materials:**
 - Annual budget
 - Program budget
 - Organizational W-9
- **Application Review:**
 - The USTA New England grant process review is a collaboration with State Associations.
 - All funding from USTA sources including USTA Foundation, State Associations, and USTA New England will be considered in funding decisions.
- **Grant Accountability:**
 - All organizations must submit a grant accountability form within three months of either completing the use of funds or the deadline specified in the award letter, whichever comes first.
 - Accountability Form requirements
 - How funds were used
 - Number of youth and adults served
 - How successful the initiative was
 - What could have gone better
 - Metrics (qualitative and quantitative) that show the success of the initiative
 - How USTA New England was recognized as a supporter of the initiative
 - Final budget
 - Photos, promotional materials, or news related to the initiative
- **Updated Application for Each Grant Request:** An updated grant application is required for each funding request. This allows the grant committee to assess the most up-to-date program information, including delivery, impact, and challenges, ensuring an equitable evaluation process.

By adhering to these guidelines, we aim to support organizations that are committed to creating positive change and making a lasting difference in our community.

Priority Criteria:

Funding requests that demonstrate the following criteria will be given priority consideration:

- **Sustainability:** Programs and projects that have a clear plan for long-term sustainability.

- **Additional Funding Sources:** Grant requests that have secured additional funding sources to support the program or initiative.
- **Inclusivity:** Organizations and initiatives that actively promote and support inclusive tennis programming, coach development, and accessibility.
- **Need for Expansion/Impact:** Clearly articulated need for financial support (e.g., projected participant increase, expansion of service areas) and opportunity to create a deeper impact within the community.
- **Outreach to Grant Ambassador:** Applicants who have consulted with USTA New England Grant Ambassadors ([see list below](#)) will be given priority in the review process.

Grant Ambassadors

State Association Presidents, along with select members of State Grants Committees, serve as Grant Ambassadors in this process. These Ambassadors play a vital role in supporting applicants, acting as key points of contact throughout the grant cycle. By fostering strong relationships between providers and State representatives, they help ensure applicants fully understand funding opportunities and the grant process. Additionally, these interactions enable Grant Ambassadors to effectively advocate for applicants during the collaborative review process with State representatives and the USTANE Grants Committee.
